
Southern Terminus Resolution (passed 1/5/2016): Pursue Travelers Trail, add a 2nd platform at Burnsville Pkwy

- Establishes station platforms at Nicollet Ave and at Burnsville Pkwy.
- I-35W Solutions Alliance passed support resolution 1/14/2016, serving as Orange Line Policy Advisory Board
- Metropolitan Council will adopt location into a Project Plan Update in 2016
- Defines scope for design and environmental project phases
- Ongoing collaboration through design with project partners


Anticipated Capital Sources, in Millions (secured/total, \$Millions)

Orange Line Funding- Phase I

- Estimated capital cost: \$150M (2017 \$)
- Committed funding: \$36.5M (24%)
- Funding shares
 - 50% Federal
 - 30% CTIB
 - 10% State
 - 10% Local


Local Funding Proposal- Phase I

- Developed jointly by staff at two counties
 - \$12.78M Hennepin (86% of local share)
 - \$2.08M Dakota (14% of local share)
 - Based on corridor length and stations
- Use of funds in advance of FTA Commitment
 - Mitigate project risks prior to FTA evaluation
 - Increase FTA Small Starts financial rating
 - Advances time-sensitive coordinated projects

2016 Funding Request- Phase I



Development Revenue Sources, Millions 2016 Project Development Activities: \$20 million

- Professional Services- Design/Engineering
 - Up to 60% CTIB funding
 - 40+% State, Metro Council
- Right-of-Way (ROW) Acquisition
 - 60% CTIB
 - 20% State
 - 20% Local: Regional Railroad Authorities (86% HCRRA, 14% DCRRA)
- Proposed 2016 DCRRA Amount: \$433,720
- HCRRA, CTIB, and proposed DCRRA funds are conditional on proposed state match



Upcoming Funding Milestones

- Remaining local funding commitment
 - Help secure state and CTIB commitments
 - Needed for strong FTA application- preparing for summer 2016 submittal
 - FTA Financial Rating accounts for 50% of overall project rating
- Counties Transit Improvement Board (CTIB)
 - Included in CTIB Program of Projects
 - Spring/summer 2016 funding commitment (for FTA application)
 - \$11 million committed in grants to-date
- 2016 State Legislature
 - \$12.1 million requested
 - Full amount needed 2016 session for FTA application
 - Partial amount needed to support 2016 work program





Action Requested

 Authorization to execute an agreement with Metropolitan Council (Council) to provide Dakota County Regional Railroad Authority (Authority) funds for the METRO Orange Line Bus Rapid Transitway.

 Authorizes agreement to provide requested share for 2016 of \$433,720 for corridor land acquisition activities

- Contingent on CTIB, HCRRA, and Council/State Shares
- Action on remaining \$1,648,030 funding commitment to be considered at a future date
