- Secured \$39.63M for the project in 2016, bringing total committed funding from all sources to \$64.52M
- Lake Street 90% plans complete, costs stable
- 12th Street Ramp 100% plans complete, costs stable
- 60% cost estimates for all other elements expected in Q2 2017







Preliminary Hazards Analysis & Threat Vulnerability Assessment

Preliminary Hazard Analysis (PHA)

Identifies, assesses and resolves the hazards associated with the system as an integral part of certifying that the representative transit system/mode is safe and reliable prior to revenue service.

Threat Vulnerability Assessment (TVA) – sensitive, secure document

Identifies threats and vulnerabilities and provides recommendations for their elimination or control during all life-cycle phases;

Identifies security measures and activities designed to reduce risk and relative likelihood of occurrence and/or potential consequences of the identified threats
